

OAK VILLAGE NORTH PROPERTY IMPROVEMENTS AND/OR HOME ADDITIONS REQUIREMENTS

1. APPROVAL FOR CONSTRUCTION IS FOR 90 (NINETY) DAYS. IF THE BUILDER FAILS TO START CONSTRUCTION DURING THE 90 DAY PERIOD, THE APPROVAL FOR CONSTRUCTION WILL BE WITHDRAWN AND THE BUILDER OR HOMEOWNER WILL BE REQUIRED TO RESUBMIT ALL DOCUMENTS AND FEES.
2. CONSTRUCTION OF THE ADDITION OR OUT BUILDING MUST BE COMPLETED WITHIN SIX MONTHS FROM THE DATE THE FOUNDATION FORMS ARE IN PLACE.
3. ALL SET BACKS MUST MEET OVN OR BULVERDE CITY REQUIREMENTS, WHICH EVER IS MORE RESTRICTIVE.
4. TEMPORARY SANITARY FACILITIES AND A DUMPSTER MUST BE PROVIDED FOR EITHER A HOME ADDITION OR OUTBUILDING REQUIRING A FOUNDATION .
5. ALL MASONARY REQUIREMENTS MUST MEET EACH OVN UNIT REQUIRED AMOUNT. THE ARCHITECTURAL COMMITTEE WILL NOTIFY THE BUILDER OR HOMEOWNER IF SUBMITTED PLANS DO NOT SHOW THE REQUIRED AMOUNT OF MASONRY AS MEASURED BY THE ARCHITECTURAL COMMITTEE.
6. A NON-REFUNDABLE CHECK FOR \$50.00 (Fifty dollar) WILL BE MADE PAYABLE TO OVNPOA FOR PLAN APPROVAL.

NOTICE

ALL SIGNS AND PERMITS MUST BE VISIBLY POSTED ON THE PROPERTY PRIOR TO THE START OF CONSTRUCTION. IF THE SIGNS ARE NOT IN PLACE WHEN CONSTRUCTION HAS BEGUN, YOU WILL BE SUBJECTED TO A \$50 A DAY FINE PAYABLE TO OVNPOA.

If builder/owner should make any changes to the exterior or size of the residence after approval has been received from the architectural control committee, the builder/owner must get approval from the architectural control committee before proceeding with the changes.

Builder will keep the project site free of construction debris and trash each day. Construction debris and trash will not be burned, allowed to accumulate, or be stored on the project site or adjacent lots.

Builder, vendor, or subcontractor will not dump or store materials in any street or block any street during construction.

The builder is restricted to use the lot on which the residence is being constructed and will not trespass or use adjacent lots for haul roads, disposal area or storage of materials.

Signs must be removed upon project completion.
